

5G Space Appeal

Why do leading scientists, professors, epidemiologists, physicians, environmental and health organizations around the world sign the *5G Space Appeal*? And how is it possible that so few people are aware of this important appeal and the underlying (scientific) information?

Dear Sir/Madam,

Digitalization is changing our society at a rapid pace and the social debate is currently focusing on fundamental questions regarding privacy and digital security. Let's Talk About Tech wants to use this letter with the [5G Space Appeal](#)¹ as an appendix to draw attention to another fundamental issue, namely whether and to what extent a healthy living environment is at stake. This issue is particularly pressing with the intended roll-out of the fifth generation wireless network (5G).

Due to 5G substantial increase in radiation in the immediate living environment

5G enables everything and everyone to be wirelessly connected to the Internet anywhere, anytime. Companies and public authorities enthusiastically introduce 'smart' homes, 'smart' companies, 'smart' highways, 'smart' cities and self-driving cars. However, no research has been carried out into what the rollout of 5G and the substantial increase in radiation in the living environment means for our health and ecosystem. Also, the digitization strategy does not take into account the many proven biological adverse effects that occur far below the current exposure guidelines of the ICNIRP. Very recently, several organisations working together under the banner of 'Eerlijk over straling (Honest about radiation)' have indicated in a joint urgent letter ['Vision on government digitalization strategy'](#)² that they are very concerned about the health damage caused by electromagnetic fields and radiation, that this damage is already serious and will increase considerably with the present plans. This urgent letter was sent to members of various parliamentary committees (including CIE Economic Affairs and CIE Living Environment).

Now many scientists, physicians, engineers and tech professionals worldwide are warning through the *5G Space Appeal* that the 5G plans threaten to cause serious, irreversible consequences for humans and permanent damage to all the Earth's ecosystems. They highlight the need for immediate action to protect humanity and the environment and, through this international appeal, call on the UN, WHO, EU, Council of Europe and governments of all countries to stop the roll-out of 5G on Earth and in space.

Why do we offer you this information?

We are not surprised if this important information is new to you. When it comes to being informed about the developments in the field of health and wireless technology, most people are very poorly informed. Why is that?

We have given this task mainly to health councils, committees and so-called knowledge platforms. Telecom stakeholders are usually represented in these committees, have short lines of communication with policy makers and also influence the decision-making process in other ways. It is well known that effective lobbying by companies leads to policy makers systematically putting financial gain before public interest. In addition, in the case of the Telecom sector, the government has auctioned frequencies for billions of euros (and in 2019 again plans to do so for 5G) and thus also has major financial interests in a problem-free roll-out of the technology. In recent years, a situation has risen in which a dominant story has taken a strong position in our society. That story is that our technology is safe, that further research must be and that there is no justification for intervening or even increasing the knowledge of, for example, the Municipal Health Services or the government.

We are an expert group of people who have directly experienced complaints of wireless technology and in this way have become interested in the knowledge, processes and state of science about electromagnetic fields and health. Our curiosity has provided us with shocking, disturbing and fascinating information. Unfortunately, it appears that information to which citizens are entitled and which politicians and policymakers need in order to make well-founded responsible choices is not shared through the appropriate channels (government agencies, national media). For example, it remains unknown to many that there are countless scientists, epidemiologists, doctors and electrosensitive people worldwide who are trying to draw attention to a more real story: our current technology is not unlimited, it is already exceeding health limits and has environmentally harmful effects. There are plenty of peer-reviewed studies that show harmful health effects to take action. For example, effects have been demonstrated in terms of normal brain function, fertility, DNA damage and cancer.

In the *5G Space Appeal* you will find extensive scientific support for the harmfulness of radiation from wireless technology. The appeal was signed by 31,291 people and organisations on 11 January 2019 and will be officially presented to the UN, WHO, EU, Council of Europe and governments of all countries. We, the expert group Let's Talk About Tech, endorse the *5G Space Appeal* with the expertise that we have gained in recent years. We hereby invite you to take note of this international call and to support our 'wake-up call' by bringing it to the attention of your network.
